"Candidates should be an Indian National and should have Passed HSC (Std XII) examination or its equivalent examination with subjects English, Physics, Chemistry, Mathematics (PCM) and or (PCMB) Biology and secured minimum 50% marks (minimum 45% marks in case of candidates of Backward class categories and Persons with Disability belonging only to Maharashtra State)

Candidate who have passed Diploma course in pharmacy (ER 1991) with minimum of 45% marks from AICTE approved colleges from Maharashtra State or its equivalent will also eligible for the admission to First Year B. Pharm. (I Semester) Course. "
