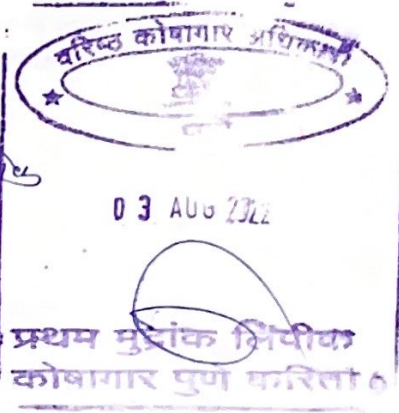

- Janaseva Foundation and Bharati Vidyapeeth (Deemed to be University) Homoeopathic Medical College & Hospital, Department of Post Graduate Research Center will organize -Guest Lectures / Seminars for Teachers and Students to enhance their knowledge and to Create awareness among them.
- Janaseva Foundation and Bharati Vidyapeeth (Deemed to be University), Homoeopathic Medical College & Hospital, Department of Post Graduate Research Centre will undertake Surveys and Research Projects.
- The MOU is Non-exclusive and each party shall be free to enter similar Collaborations with other Institutions /Organizations.
- The Parties to this MOU Unless expressly stated in any subsequent written agreement shall have no obligation to Compensate the other in any manner. Each party shall bear their respective expenses incurred under this MOU.
- This MOU is Valid for a time Period of 5 Years.
