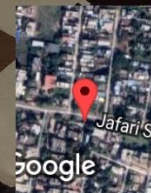

Total 141 subjects were screened and Colgate toothpaste distributed. They mostly suffered from Caries. Subjects requiring the treatment were referred to BVDU Dental College and hospital for needful treatment at concessional cost. Referral cards were given to the patients for the discount in the treatment procedures. The team left the venue at 12.25 P.M. and reached the college at 12.45 P.M.
