This University came into existence in April, 1996 when the Ministry of Human Resource Development, Government of India on the recommendation of the University Grants Commission declared a cluster of institutions of Bharati Vidyapeeth as Deemed to be University. At present the university is having 29 constituent colleges with 8 schools and 6 centres and Departments. The University is functioning as per the University Grants Commission (Institutions Deemed to be Universities) Regulations 2023.

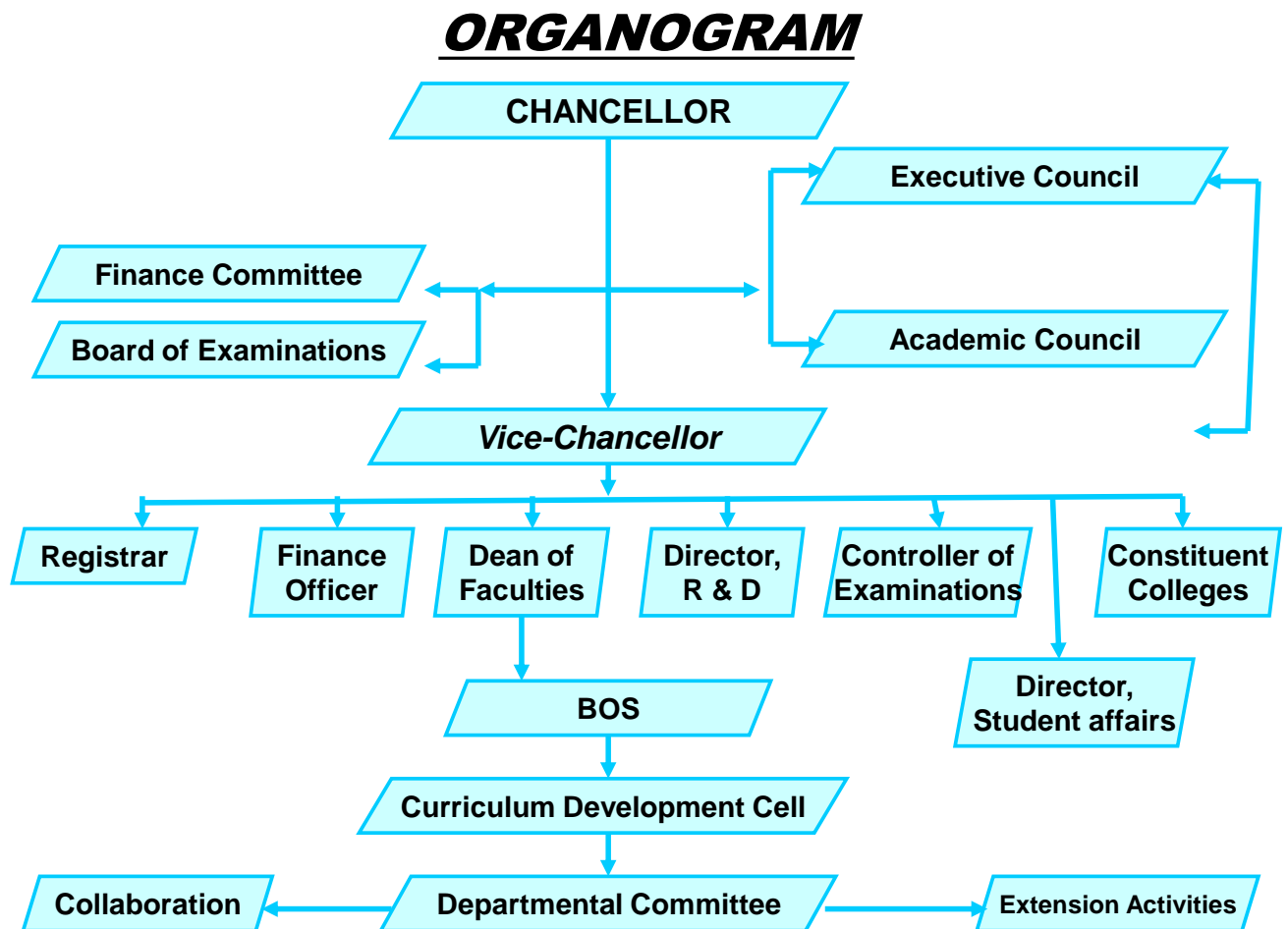
