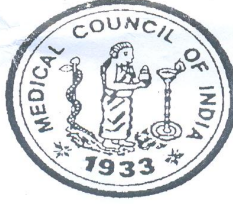

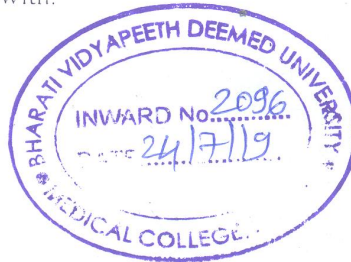
Sir/Madam,

I am directed to state that the Board of Governors considered the compliance submitted by the college authorities vide letter dated 17.05.2019 and previous assessment reports (March, 2019 & June, 2017) on the standard of examination and other teaching facilities available for recognition of MD(Psychiatry) qualification against increased intake from 02 to 03 seats in respect of students being trained at Bharati Vidyapeeth Medical College, Pune. granted by Bharati Vidyapeeth University (Deemed), Pune and Committee decided as under:-

*The Board of Governors considered the compliance submitted by the college authorities vide letter dated 17.05.2019 and previous assessment reports (March, 2019 & June, 2017) together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that MD(Psychiatry) qualification against increased intake from 02 to 03 seats granted by Bharati Vidyapeeth Deemed University, Pune in respect of students being trained at Bharati Vidyapeeth Medical College & Hospital, Pune be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.*

*The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.*
