I am directed to state that the Board of Governors at its meeting held on 11.02.2019 considered the Compliance Verification Assessment report (06.08.2018) along with the Council Assessor's Report(s) (December, 2017) and compliance dated 01.03.2018 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of MS(General Surgery) qualification for 10 seats at Bharati Vidyapeeth Medical College & Hospital, Pune granted by Bharati Vidyapeeth Deemed University, Pune and decided as under:-

"The Board of Governors considered the compliance verification assessment report (06.08.2018) along with the Council Assessor's Report (December, 2017) and compliance dated 01.03.2018 submitted by the college authorities together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MS(General Surgery) qualification for 10 seats granted by Bharati Vidyapeeth Deemed University, Pune in respect of students being trained at Bharati Vidyapeeth Medical College & Hospital, Pune be renewed.

The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
