Sir,

I am pleased to inform you that, this university has taken all precautions to prevent ragging in this university. Some of the steps taken by the university are as follows:

- 1) At the time of admission all the students and parents are clearly informed of the ill effects of ragging and asked them not to involve in ragging.
- 2) The senior students are also informed of the punishments to be imposed on those students involved in any form of ragging viz., teasing, abuse, physical torture etc.
- 3) The students as well as the parents are executing an affidavit as prescribed in the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009.
- 4) Hoardings (Picturized) are displayed in the prominent places including the entrance of colleges, highlighting the points mentioned in the Curbing the Menace of Ragging in Higher Educational Institutions, 2009 regulations.
- 5) Posters (contents are - ragging in any form is strictly prohibited, type of punishment, fine and expulsion from the university etc) are printed and displayed in the notice boards as well as in the hostels, library, canteen etc.

- 6) Anti ragging squads formed in every institution and periodical visits are carried out by the anti ragging squad.
- 7) Anti ragging committee has been formed to have over all monitoring of the anti ragging activities.
- 8) The wardens in the hostels and Principal/Directors of the institutions are directed to take immediate action in accordance with the Curbing the Menace of Ragging in Higher Educational Institutions Regulations.
- 9) The mobile number of the Principals, Wardens, Nodal Officer and anti ragging committee/squad Chairman's are prominently displayed in the colleges, hostels and institution websites.
- 10) The UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009 have been printed and sufficient booklets are kept in all the libraries of our colleges for the students study and reference.

I once again state that, this university has taken adequate steps to prevent ragging and they have given the fruit of no ragging in our campus.
